Entity's Purpose or Mission

The Duncan Foundation aims to provide new and essential clinical services to improve the lives of New Zealanders with neurological conditions that impact physical function. We provide:

- services for a person and their whanau to access clinical resources and allied health professionals who understand the management of progressive neurological conditions regardless of regional, cultural, and socio-economic barriers.
- the opportunity for health professionals working remotely or in isolation to access clinical and collegial support when working with people living with progressive neurological conditions that impact physical function.

Entity Structure

Governance: The Board of Trustees can be made up of between three and seven Trustees, there are currently 3 Trustees.

Operations: 3 part-time contracted staff (CEO, Patient & Admin Coordinator and Funding). Volunteers also support our team.

Clinician Support Team: 1 contract Clinical director and 4 Clinical Lead roles (contracted through Rope Neuro Rehabilitation Ltd)

Programme Delivery: provider contracts for clinical services to patients and education to health professionals & community

Main Sources of Entity's Cash and Resources

We are grateful to our funding partners The Sir Thomas and Lady Duncan Trust and the Lindsay Foundation for their ongoing support and value our other key funders who supported us through philanthropic grant funding and donations.

Main Methods Used by Entity to Raise Funds

We are primarily funded through grants and donations received from individuals, trust and community funders.

Additional Information

The Duncan Foundation identifies gaps in allied health services available within the public health system, facilitates access to trained health professionals and provides continuing education to clinicians. Our focus is currently on supporting people living with focal dystonia, the late effects of polio, recently diagnosed Parkinson's, Friedreich's ataxia, spinocerebellar ataxia, and other inherited ataxias.

Statement of Service Performance

Duncan Foundation For the year ended 31 March 2023

Description of Entity's Outcomes

The Duncan Foundation is dedicated to improving the physical and mental well-being of New Zealanders living with various neurological conditions. Currently, we support individuals with the late effects of Polio (LEoP), idiopathic focal dystonia, recently diagnosed Parkinson's (RDP), Friedreich's ataxia (FA), spinocerebellar ataxia (SCA), and other inherited ataxias. As needs arise, we will continue expanding the range of conditions we support.

People with progressive neurological conditions face a wide range of disabilities, including chronic and acute impairments in muscle function, fatigue, and pain. Their quality of life tends to be lower compared to the general population. Unless they experience an acute event, such as a fall, there is no defined treatment pathway offered to them. However, interventions can potentially slow the rate of decline, sustain quality of life, and reduce the risk of acute events. We strive to eliminate regional, cultural, and socio-economic barriers to ensure equitable access to our services.

Increasing awareness of condition-specific management and providing timely access to appropriate services without financial barriers are key drivers of our work.

The Duncan Foundation's network of clinicians provides comprehensive clinical assessments, treatment, and appropriate referrals to individuals living with neurological conditions. Through collaborative efforts, we develop self-management tools that improve quality of life and symptom management. Additionally, we support our network of clinicians by facilitating resource sharing, peer reviews, journal reviews, and continuous professional development.

Our goals extend beyond clinical services. We strive to advance knowledge of these conditions within the broader health and community sector. This involves delivering educational presentations, participating in research, and collaborating with patient groups to understand current needs, available services, and develop treatment protocols and outcomes. Notable activities during the period ended 31 March 2023 include:

- Presentations to community groups

 - FARA NZ Friedreich's ataxia information forum
 - Muscular Dystrophy New Zealand
 - Parkinson's New Zealand regional clinical educators
- Presentations to health professionals within Te Whatu Ora
- Waitakere and North Shore Hospital clinicians regarding RDP
- Te Whatu Ora inpatient, acute and rehabilitation physiotherapists
- Regular condition-specific journal clubs, peer support and education sessions for Duncan Foundation's network of affiliated clinicians
- Participated in
- Centre for Brain Research Parkinson's Steering Group with a goal to build better health outcomes for all Parkinson's patient in NZ irrespective of ethnicity
- Regular PINK1 group education sessions which provide an opportunity to connect with PINK1 individuals and understand their perspectives and challenges
- Neurogenetics Research Clinic ataxia satellite clinic in Taranaki
- Held
 - 3 x six-week condition-specific Fatigue Management courses (2 x ataxia, 1 x polio)
 - a collaborative Physiotherapy and Orthotist clinic for Polio patients in the Waikato
 - Peer Support Groups: In collaboration with Polio New Zealand, we held 98 online Polio morning & afternoon tea sessions with 1245 attendances over the year.

Since our establishment, the Duncan Foundation has consistently increased the number of patient referrals from neurologists, allied health professionals, general practitioners, and community support groups. As of 31 March 2023, we were working with 23 Duncan Foundation-affiliated clinicians in nine regions throughout New Zealand.

In collaboration with the Centre for Brain Research, our involvement in the Neurogenetics Research Clinic focused on providing neuro physio and occupational therapists experienced in working with neurogenetic conditions.

We are proud of the progress we have made in serving the neurological community and will continue striving to make a positive impact on the lives of individuals living with progressive neurological conditions.

Statement of Accounting Policies

Duncan Foundation For the year ended 31 March 2023

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Duncan Foundation is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Revenue

Unconditional Grants, Donations, sponsorship and fundraising

Revenue from unconditional grants, donations, sponsorship and fundraising are recognised when the funds are received.
